

PRIVACY POLICY (GDPR)

Article 1: PREAMBLE

The company EMOBDEV SAS has for priority the ethics of its services and the respect of the data and the users: the confidentiality of your personal data is important for our company. In this document, we present our policy on the information, collection and processing of your personal data and the procedures for accessing, modifying, deleting and portability of your data.

In this document, we present the privacy policy applied to the site: <http://www.emobdev.fr>, and to the domains that are redirected to it: <http://emobdev.fr>, <http://emobdev.com> and <http://www.emobdev.com>, referred to in this text as "the EMOBDEV website" including the following information:

- The information we collect and the collection methods used
- User rights
- The third parties to whom the data are transmitted
- Cookie Policy

In summary, we have endeavoured to design the EMOBDEV website in such a way that we do not collect your data, except for those that are sent to us via the contact form.

The company EMOBDEV is the publisher of the EMOBDEV website.

EMOBDEV is a simplified joint stock company (SAS), with a capital of €15,000, registered with the RCS of Nice, in France, under the number 838835981.

Article 2: DATA COLLECTION AND PROCESSING POLICY

In accordance with the provisions of [Article 5 of the European Regulation 2016/679](#), the collection and processing of data of the users of the site respect the principles recommended by the General Data Protection Regulation (GDPR), including but not limited to:

- Legality: what the law says,
- Purposes: what the data are used for,
- Conservation: storage methods and duration,
- Integrity and confidentiality: non-disclosure, protection against unauthorised access.

What the law says (summary):

- The user must expressly consent to the processing,
- The processing is necessary for the proper performance of the contract,
- The processing is in response to a legal obligation,
- The processing is necessary to protect the vital interests of the data subject or of another natural person,
- The processing can be explained by necessity linked to the performance of a task in the public interest which falls within the exercise of public authority,
- The processing and collection of personal data is necessary for the legitimate and private interests pursued by the controller or a third party.

Article 3: DATA COLLECTED AND PROCESSED IN THE CONTEXT OF NAVIGATION ON THE SITE

A. Data collected and processed, mode of collection

The following data may be collected from this site:

- Name or alias sent via the contact form
- Email address sent via the contact form
- Content of the message sent via the contact form

This data is collected when the user performs the following operations:

- Sending a message via the contact form

The data received via the contact form can be forwarded to the company contact concerned by the mail. The messages are kept for a period of one year in the company's webmail inbox hosted by OVH. In the event that this data is processed or stored in another way, the sender will be informed in order to obtain his prior consent.

The collection and processing of data received via the contact form is for the following purposes:

- Reply to messages sent via the site's contact form

The data processing carried out on the data will comply with the following legislation:

- User consent

B. Transmission of data to third parties

The data collected via the site are not transmitted to any third party and are only processed by the site editor. In the event that the processing requires the intervention of a third party, the user will be informed in order to obtain his prior consent.

C. Data hosting

The data collected and processed by the site are exclusively hosted and processed in France.

Article 4: PERSON RESPONSIBLE FOR THE PROCESSING OF DATA

A. Contacting the data controller

The controller of the personal data is:

- Ms Anne-Marie Lesas.

The data controller can be contacted as follows:

- Via the contact form

The data controller is responsible for determining the purposes and means of processing personal data.

B. Obligations of the data controller

The data controller undertakes to protect the personal data collected, not to pass them on to third parties without the user's explicit consent and to respect the purposes for which the data were collected.

The data controller undertakes to inform the user in the event of rectification or deletion of the data in the event that the data collected has been the subject of a particular processing operation for which the user has given his prior consent, unless this entails additional costs for the user of which he has been informed in advance and the modification or invoicing of which requires the prior consent of the user.

The data controller undertakes to inform the user concerned by any means in the event that the integrity, confidentiality or security of the user's personal data is compromised.

Article 5: RIGHTS OF THE USER

A. Users' rights regarding data collection and processing

The user may request to view, update, modify or delete his or her data in the following way:

- Contact form

B. Right to data portability

The user may request the portability of the data held by the site concerning him/her to another site by the following means:

- Contact form

C. Right to limit and object to data

The user has the right to request the limitation or to oppose the processing by the site of data concerning him/her without this request being refused, unless he/she can demonstrate the legitimate and imperative character that may prevail over the interests and rights and freedoms of the user.

The request to limit or oppose the processing of the user's data by the site is made in the following way:

- Contact form

D. Right not to be subject to a decision based exclusively on an automated process

In accordance with the regulations, the user has the right not to be subject to a decision based exclusively on an automated process if this decision has a direct or indirect impact of a significant legal or financial nature.

E. Right to determine the fate of data after death

In accordance with the regulations, the user can ask to organise what happens to his or her personal data in the event of death.

F. Right to refer to the competent supervisory authority

In the event that the user finds that the personal data collected is not being processed in accordance with the regulations or that the user believes that his or her rights listed above are being infringed, the user is entitled to refer the matter to the National Commission on Information Technology and Civil Liberties (CNIL: <http://cnil.fr>) or any other competent court.

G. Personal data of minors

In accordance with the regulations, only minors aged 15 or over may consent to the processing of their personal data.

For users under the age of 15, the consent of a legal representative is required for the collection of personal data.

The site editor reserves the right to verify by any means that the user is at least 15 years old, or that he/she has obtained the agreement of his/her legal representative to transmit personal data.
